- **1.0 SCOPE:** This specification establishes the requirements for employee certification associated with the techniques listed herein, applicable to Seller's personnel.
- **2.0 PURPOSE:** The techniques listed herein provide the list of processes, operations, and/or inspections representing a selected skills baseline for which certification requirements have been established.
- 3.0 <u>APPLICABILITY:</u> The requirement for employee certification is applicable to Seller's employees who perform a specific process, operation or inspection task associated with the techniques listed herein when this document is specifically included in the contract document, purchase order or statement of work and the technique is required in the manufacturing or inspection process for the described product.

4.0 GENERAL NOTES:

- 4.1 The following employee certification techniques listed herein represent the total techniques established and approved at the date of this document. The table provides:
 - 1. certification/technique;
 - 2. Buyer's curriculum number (for reference only);
 - 3. requirement origin;
 - 4. recertification frequency (if applicable).
- 4.2 Buyer's inputs for IQCS-460 are derived from Regulatory requirements, Customer/Contractual requirements and corporate requirements. Additional industry standards, engineering specifications, material specifications and process requirements listed in the PO will have certification and/or qualification requirements also applicable to Seller's employees and/or facilities.
- 4.3 Seller shall train and certify employees to ensure such employees have the skills, knowledge, and ability to satisfactorily and safely accomplish applicable techniques required by IQCS-460. This task is required regardless of administrative statements contained in any industry standard.
- 4.4 Seller's employees who perform a specific process, operation or inspection task shall have a current certification in that technique listed herein. Seller shall certify such employees prior to assigning one or more such employees to perform the task.

4.5 Seller shall submit an employee certification program plan to Buyer's employee certification board (via the Buyer's Material Management representative) for approval. Such plan shall outline, in detail, methods for implementing the requirements of IQCS-460. At a minimum, such plan shall include the following:

- identification of the techniques requiring certification which will be used in the manufacturing, processing and/or inspection of the product described in the contract document:
- 2. training program leading to certification, including a copy of the outline used in each technique/discipline;
- 3. resumes of trainers/instructors showing the educational achievements/experience which establishes his/her expertise;
- 4. a listing by technique/discipline, of all names of certified employees. The listing shall also include a description of the stamp or other means used by the certified employee to identify his/her work, if any:
- 5. provisions for systematic review and recall of personnel for recertification. Criteria for certification shall be documented, auditable and available for review by the buyer's quality assurance representative;
- 6. provisions for maintenance of certification records for all certified personnel for the life of the PO.
